
### **Program History**

The City of Dallas implemented Safelight program to reduce high number of right angle collisions and related injuries/fatalities due to red light running.

- City of Dallas started the program in 2006 with a 10 year contract.
- In 2017, the City of Dallas went into a new contract with a new vendor for 8 years.
- Our current program has 29 intersections with active 51 Red Light camera.




#### Citations Issued by Fiscal Year
