114th Congress, 1st Session Key Dates & "Cliffs"

- February 2: President Obama releases FY 2016 Budget Proposal
- February 28: Homeland Security funding expires
- March or sometime thereafter: Debt ceiling reached
- March September: FY 2016 appropriations process

114th Congress, 1st Session Key Dates & "Cliffs"

- May: Highway & Transit programs expire & Highway Trust Fund depleted
- September 30: Aviation programs expire
- September 30: Internet Tax Freedom Act expires
- October 1: FY 2016 begins

114th Congress, 1st Session Key Issues

- Budget
 - Sequestration is back for FY 2016, putting pressure on all discretionary spending, especially core local government programs

114th Congress, 1st Session Key Issues

Tax

- Congress will take a hard look at corporate tax reform; comprehensive tax reform; for cities: tax exemption for municipal bonds is the key issue.
- Extenders: New Markets Tax Credits, Work Opportunity Tax Credit, sales tax deduction, etc.

114th Congress, 1st Session Key Issues

- Transportation
 - Highways & Transit
 - Aviation
 - Passenger/High Speed Rail
- Infrastructure
 - Water Resources Development Act ["WRDA"]
 - Water & Wastewater

General Statements of City's Legislative Focus

- Oppose any federal action that:
 - Erodes the home rule authority of municipalities,
 - Imposes unfunded mandates; or
 - Constrains the ability of cities to allocate resources to locally-determined priorities.

General Statements of City's Legislative Focus

- Support legislation that:
 - Creates opportunities for individuals and businesses to thrive and prosper,
 - Provides an equitable distribution of federal funds; and
 - Addresses the concerns and issues confronting large metropolitan cities, including urban transportation, crime reduction, affordable housing and healthy neighborhoods.

General Statements of City's Legislative Focus

- Unfunded Mandates
 - Oppose unfunded federal mandates.
- Deficit Reduction
 - Support a balanced approach to deficit reduction; reduction should not disproportionately harm national defense or core local government programs, nor should it delay much-needed investments in infrastructure.
