BACKGROUND

This five-year concession contract, with one three-year renewal option, will provide for tennis center pro/manager management. For the past 38 years, the Park and Recreation Department has utilized a public/private partnership to manage and operate the City's tennis centers which operate 364 days per year. The pro shop operations at each facility are managed by a certified tennis professional through this contract. The tennis professional is responsible for management, operation, staff, programs, and marketing of their respective facility at their expense. Activities conducted by each tennis professional include: tournaments, leagues, lessons, merchandising, and concessions. Park and Recreation Department staff maintain the grounds.

The City owns five full-service tennis centers:

- Fair Oaks Tennis Center, 7501 Merriman Parkway
- Fretz Tennis Center, 14700 Hillcrest Road
- Samuell-Grand Tennis Center, 6200 E. Grand Avenue
- Kiest Tennis Center, 2324 W. Kiest Boulevard
- L.B. Houston Tennis Center, 11225 Luna Road

The committee selected the successful respondents on the basis of demonstrated competence and qualifications under the following criteria:

•	Overall approach	40%

•	The City and capital Improvement	30%

As part of the solicitation process and in an effort to increase competition, the Office of Procurement Services used its procurement system to send out 2,894 email bid notifications to vendors registered under respective commodities. To further increase competition, the Office of Procurement Services uses historical solicitation information, the internet, and vendor contact information obtained from user departments to contact additional vendors by phone. Additionally, in an effort to secure more bids, the Office of Business Diversity's ResourceLINK Team sent notifications to 25 chambers of commerce and advocacy groups to ensure maximum vendor outreach.

Hector Alcalde and Paul Schlesinger provide the City with advice, assistance and advocacy services to achieve the City Council's designated legislative objectives in the areas of water resources, flood control and transportation. To date, they have worked to secure over \$220 million in federal funding for the City.
