MAKEUP OF THE HOUSE AND THE SENATE

The Dallas Delegation is co-led by Rep. Linda Koop and Rep. Eric Johnson

- The House of Representatives
 - 95 Republicans
 - 55 Democrats
- HB I
 - Sets spending at \$108.9B
 - Prioritizes public education, CPS reform and Mental Health Funding
 - Reduces General Government funds by \$1.2B
 - Decreases Business and Economic Development funds by \$623M

- The Senate
 - 20 Republicans
 - II Democrats
- SB I
 - Sets spending at \$103.6B
 - Prioritizes transportation resources and CPS reform
 - Imposes a 1.5% across the board reduction in Article IX (General Provisions)
 - \$800M decrease in Higher Education

LEADERSHIP AND EARLY PRIORITIES

- Governor Greg Abbott delivered his State of the State address and laid out the following emergency items:
 - Reforming CPS
 - Banning Sanctuary Cities
 - Ethics Reform
 - A resolution calling for a Convention of States

- Joe Straus was unanimously reelected as Speaker of the House. His priorities include:
 - Mental Health
 - Reforming CPS
 - Public EducationFinance Reform


- Lieutenant Patrick gaveled in the Senate and put forth the following agenda:
 - Property Tax Reform
 - Banning Sanctuary Cities
 - Women's Privacy Act
 - School Choice

MAJOR BILLS OF INTEREST

As of February 9, there have been 2,530 bills filed in the Senate and the House.

Bills of Interest

- **SB 2 (Bettencourt):** Imposes a 4% rate cap on property taxation, mandatory elections for certain rate increases, and other property tax changes
- **SB 4 (Perry):** Looks to prohibit sanctuary city policies that forbid local law enforcement from inquiring about a person's immigration status and complying with detainer requests
- **SB 6 (Kolkhorst):** Mandates people to use public restrooms that match their biological sex
