Background/History

- Chapter 17 provides food safety regulations for food establishments in the city of Dallas that is in addition to the State of Texas Food Establishment Rules
- In FY 12-13 Code Compliance Consumer Health fees were studied and Council adopted new fee rates on October 23, 2013, amending Chapter 17, "Food Establishments" of the Dallas City Code
- MGT Consulting was hired by the Office of Financial Services to conduct a fee study for the FY 17-18 Code Compliance Consumer Health fees
 - Analysis of the time increments and costs associated with staff time to provide Consumer Health services was conducted to capture full cost recovery
 - The fee study recommendations were apart of the City Manager's recommended FY 17-18 and FY 18-19 Proposed Budget that was briefed on August 8, 2017

Background/History (continued)

- In conjunction with the fee study:
 - City staff is recommending a provision to Chapter 17 to include the practice of "blanketing" temporary food service fees, or
 - enforce the current ordinance as stated, which would eliminate the practice of "blanketing"
- In addition, City Council has expressed interest in modifying Chapter 17 to allow for annual permitting of food truck trailers

- New Fees:
 - 3) Non time and temperature control product sampling:
 - For shelf stable foods:
 - Canned or bottled beverages
 - Individually wrapped commercial prepared foods
 - i.e. granola bars, chips, energy bars, etc.
 - Does not include products that must be cooked, mixed or served with utensils
 - Currently product sampling vendors must apply for a temporary food service permit



Blanketing Temporary Food Service Permits

- Blanketing is the practice of offering an exception or variance to temporary food service events in Dallas
- Current temporary food service permit is \$156 per booth, plus \$7 a day; (FY 17-18 Proposed Fee is \$121 per booth, plus \$13 a day)
- Reasons for blanketing include incentives for economic development initiatives:
 - Hotel occupancy
 - Utilization of Kay Bailey Hutchison Convention Center
 - Increased sales tax synergies



- Issues with blanketing include:
 - Practice of blanketing is not included in Chapter
 17
 - The City is not recovering its full cost to ensure compliance of food regulations for these events
 - Blanketing can create a lack of accountability for vendors to be trained and uphold City regulations; permits are typically held by the event coordinators and not by each vendor





Annual Permit Fee for Food Trailers (Continued)

Mobile Food Truck

- The City has a process to permit mobile food trucks annually
 - Must meet Plan Review Process and Quality Standards
 - Must have permission from private property owner and cannot be on public property, public right away, or in residential areas

Food Trailer

- The City does not currently have a process to permit a food trailer
 - A trailer must be propelled by another vehicle
- Food trailers must apply for a temporary permit



Annual Permit Fee for Food Trailers (Continued)

- Council has expressed an interest in looking into a way to annually permit food trailers
- Considerations:
 - Trailers must meet same review process and quality standards as the mobile food truck
 - Participation would be for temporary events only
 - No more than 14 consecutive days per calendar quarter

There are currently four contracts under which TCEQ funds the City's Ambient Air Monitoring Group to monitor local air quality and also purchase and maintain necessary equipment.

This action addresses Contract No. 582-15-50031 for the Ambient Air Pollution Monitoring Program. The Texas Commission on Environmental Quality (TCEQ) requested that the City of Dallas operate the Rockwall (Rockwall County) continuous ambient air monitoring station as a part of the City's and Dallas/Fort Worth region's ambient air monitoring network. TCEQ purchased and installed major components of the station and will maintain these components at their expense, including all hardware and equipment required for the facility to be operational. BACKGROUND

Since 1967, the City of Dallas has worked with the Texas Commission on Environmental Quality (TCEQ) and its predecessor agencies, to support clean air monitoring and enforcement of air quality regulations through a set of renewing contracts for services. There are currently four contracts under which TCEQ funds the City's Ambient Air Monitoring Group to monitor local air quality and also purchase and maintain necessary equipment.

This action addresses Contract No. 582-16-60016 which ensures the monitoring of biological contaminates that could be associated with a bioterrorist attack on Dallas County. The TCEQ supports the Department of Homeland Security (DHS)'s National Whole Air Monitoring (BioWatch) network which began in February 2003 in Texas. The TCEQ in turn, contracts with the City to operate the Biowatch network of whole air samplers at various locations throughout Dallas County. Authorization of this contract will allow for the City to accept TCEQ funds for FY '18, and enable the City to continue the Biowatch Program. TCEQ reimburses the City of Dallas 100% of the cost associated to maintain the program.

BACKGROUND

Since 1967, the City of Dallas has worked with the Texas Commission on Environmental Quality (TCEQ) to support clean air monitoring and enforcement of air quality regulations through a set of annually renewed contracts for services.

Under this contract, TCEQ funds the City's Air Pollution Compliance program. In the City's Air Pollution Compliance program, City environmental Specialists conduct periodic inspections of industries and business in Dallas that have the potential to emit pollutants, as defined in the city code. These may include manufacturing facilities, fueling stations, paint-and-body shops, and other industrial sites. The City's specialists respond to citizen complaints of odor, smoke or other airborne pollutants, and they also review air permit requests made by potential emitters in the City of Dallas.

This action will authorize Amendment No.3 to Contract No.3 582-15-50121, renewing the service agreement through FY18. The City and the TCEQ share in the cost of this annual program, with, TCEQ funding 67% of the cost and the City providing 33% subject to annual appropriation.
