

So the FAMILY is responsible for its demolition? Even though it was caused by an Atmos gas leak?

Will the family have to pay for it? Will they be billed for it? Are they in violation of code as of now?

Are investigations done?

**City Response:** We believe that the questions of ultimate liability and whether investigations are complete should be addressed to counsel for the property owner.

Any demolition costs incurred by the City would be secured by a lien against the property.

The property in its current condition is a public nuisance in violation of the Dallas City Code.

With the Landmark Cmsn also approving removal – is there a date T.C. / the city has in mind for removal of the Confederate Memorial in Pioneer Park?

**City Response:** At this time there is no date. We will let you know once we have more information on this topic.

We would like to air an update at 6pm on what happens. Can the vote can now be appealed to the Dallas Plan Commission since the monument and the location in Pioneer Cemetery are both historic? And will that appeal happen or not?

**City Response:** Hi Hannah, The Landmark Committee approved the application to remove the confederate monument. The final vote was 10-5. Thirty days are given for the vote to be appealed, it is unknown if it will be appealed.

On Monday, Feb. 25, the Dallas Fire-Rescue Department and the City of Dallas will hold a ceremony to swear in Dominique D. Artis as the 17th fire chief. Speakers include City Manager T.C. Broadnax and Mayor Michael S. Rawlings.

**Media, please be in place and set up by 5:00 p.m. Chief Artis will be available for interviews at 5:15 p.m.**

**Thursday, February 28<sup>th</sup>: Univision 23 (Jehova Azucena)** - Can you provide us with any additional information in regards to the fire at 2000 Elm St. this morning?

**City Response** - Just before [04:00](#) (@3:58) Dallas Fire-Rescue units responded to a structure fire at the Elm Street Parking Garage, located at 2000 Elm Street, in Downtown Dallas.

When firefighters first arrived at the location they observed smoke coming from the first floor of the parking garage. Per procedure, they called for a second alarm response; but upon finding the source, most additional units were disregarded prior to their arrival.

Fire personnel found boxes on fire in an office on the first floor of the garage, and quickly extinguished the flames. The damage was contained within the office, and no vehicles in the garage were impacted.

Fire Investigators have not yet settled on the exact cause, and have therefore left the cause of the fire as undetermined at this time.

**Thursday, February 28<sup>th</sup>: All local news outlets** – Can we have more detail about a 2-alarm high-rise fire DFR is responding to in Downtown Dallas.

**City Response** – At 10:51 Dallas Fire-Rescue responded to a 911 call for a fire, in a restaurant, on the first floor of the Mosaic Lofts in Downtown Dallas.

When firefighters arrived at the scene, they observed smoke pouring into the streets from the first floor of the location. They quickly mounted an offensive fire attack and found a small fire which had made its way into the kitchen's ventilation system. Thankfully, the ventilation system isolated the fire inside of it where firefighters could locate and extinguish it without collateral damage.

Thankfully, there were no injuries reported, or evacuations ordered; and as soon as firefighters ventilate the smoke from the first floor those who self-evacuated should be able to go back inside.

**Friday, March 1<sup>st</sup>: All local news outlets** – Can we get more details on the multiple alarm fire DFR is responding to in Lake Highlands?

### **City Response –**

#### **3-Alarm Fire Displaces 45 From Northeast Dallas Apartments**

**Dallas:** At 02:19 Dallas Fire-Rescue units were assigned to a 911 call for a structure fire at the Del Rey Village Apartments, located at 9607 Wickersham Road, in the Lake Highlands area of Dallas.

As firefighters approached the location, heading down Interstate 635, they saw the flames well in advance and requested a second- alarm response. Thankfully, by the time they arrived at the two-story apartment building, residents had mostly self-evacuated. After the remaining residents were evacuated, and a third-alarm response was sent to the location to help mitigate the situation, the fire was tapped out in just under a couple of hours.

There were 16 units in the building; half of which were directly impacted by fire. The remaining 8 were affected by varying degrees of smoke and/or water damage. The entire building was ultimately determined to be a total loss, displacing all 45 of its residents; according to the American Red Cross who was there to assist with their post-incident needs. Most importantly however, there were no reported injuries to any residents or firefighters.

Fire Investigators were able to determine that the fire started in a second-floor unit, but have not been able to determine the exact cause. Considering the state of the building, it is highly probable that the cause will remain as such.

**Monday, March 4<sup>th</sup>: All local media outlets** – Can we have more information on an apartment fire DFR is responding to on Holly Hill Drive?

### **City Response -**

#### **Apartment Fire in Vickery Meadow Displaces Multiple Families**

**Dallas:** On Monday, March 4<sup>th</sup>, at 5:27a.m., Dallas Fire-Rescue responded to a 911 call for a structure fire at the Sunchase Apartments, located at 7229 Holly Hill Drive, in the Vickery Meadow area of Dallas.

When firefighters arrived at the location they observed heavy fire coming from the roof of a two-story apartment building. Suppression efforts were mostly defensive in nature; and after second and third alarms were transmitted (approximately 70 firefighters), the fire was ultimately extinguished with no injuries having been reported to any residents or firefighter who responded.

There were a total of 16 apartments in the building. Eight of those units were damaged by varying degrees of smoke, fire and /or water. According to the American Red Cross, who was dispatched to render aid to those impacted, more than 70 residents were displaced as a result of the damage.

Fire investigators believe the fire began in a second floor unit, before making its way into the ceiling space and spreading. Unfortunately, the severe damage that the building sustained made it unsafe to conduct a more thorough internal investigation; and as a result, the cause of the fire remains undetermined.

SUBJECT **Dallas Police Department (DPD) Information Update**

During the city council meeting on February 27, 2019 the Police Department was asked for clarification on the patrol bid process and a breakdown of the number of personnel assigned to call answering duties.

The patrol bid process serves two purposes. Each year it is necessary for the patrol staffing to be realigned based on retirements, transfers and promotions. The department utilizes staffing software that allocates patrol call answering personnel based on work load. This computer-based program allows officers to bid for new job assignments and days off throughout the seven Patrol Divisions in an equitable manner.

There are currently 1,843 officers assigned to the Patrol Division, and the total number of officers assigned in the bid process as primary call answering personnel is 1,380. In the most recent patrol bid, 1,219 officers participated in the process. There were an additional 89 officers that did not have enough seniority to enter the bid process, as well as another 72 trainees assigned to Patrol. These officers were automatically placed to ensure balanced adequate staffing levels at all divisions. See the chart below for a summary of the primary call answering personnel.

In addition to those officers with primary call answering responsibilities, there are 184 specialized officers with secondary call answering responsibilities. These officers' interview for their position and do not participate in the bid process. They are assigned to the following units listed below.

- Neighborhood Police Officers (NPO), Crime Response Team (CRT) Officers and Bicycle Officers.
- Storefront Officers, these officers have call answering responsibility in their geographic area such as Jubilee Park.

The balance of the total 1,843 officers assigned to the Patrol Bureau serve in support or management/supervisory positions. The support positions include 27 officers assigned to various administrative and investigative positions including administration, intelligence gathering officers, RISK detectives and crime analysts. The management/supervisory positions include 221 Sergeants (Sergeants also have secondary call taking responsibility), 22 Lieutenants and 9 Majors that are responsible for the oversight of Patrol operations. 
