SUBJECT **Margaret McDermott Bridge Status Update**

This memorandum provides an update on the status of the Margaret McDermott (I-30) Bridge project. On April 12, 2019, the City Manager, as directed by City Council at its meeting dated April 10, 2019, requested funding from the Trinity Park Conservancy to cover additional construction costs associated with the full retrofit which entails replacing all cables including a new lower cable anchorage assembly with a larger anchor rod (letter is attached as exhibit A). In addition, the City Manager requested a response from Trinity Park Conservancy no later than April 19, 2019.

The City Manager received a response letter (attached as exhibit B) from the Trinity Park Conservancy dated April 19, 2019, indicating their fundraising efforts are concentrated on the successful completion of Harold Simmons Park and that they will consider ways to help upon concluding the fundraising efforts.

In the absence of funding commitment by the Trinity Park Conservancy, the City has no other option than to move forward and pay the additional costs to get the project completed and reserves its right to pursue all other responsible third parties for these additional costs.

Dear Ms. Rose:

The City of Dallas has been working towards the completion of the Margaret McDermott Bridge with our partners at the Texas Department of Transportation (TxDOT). Through various efforts dating back to the early 2000's, funding has been secured through public and private efforts. The private philanthropic efforts were appreciated and assisted in the development of the Margaret Hunt Hill and Margaret McDermott Bridges. The City initiated these design contracts with Santiago Calatrava and construction was performed through TxDOT. The McDermott Bridge has not opened to date as a result of fatigue on the cable anchorage system. In an effort to resolve the issues surrounding the cable anchorage system, the design team led by Santiago Calatrava has developed a solution that required replacing the existing cable anchorage system with a larger rod and additional dampeners. TxDOT's contractor has agreed to perform this work and priced the replacement and associated actions at \$7,091,014.

At the City Council meeting on April 10, 2019, the City Council authorized the payment to TxDOT, contingent upon formally requesting funding from the Trinity Park Conservancy (TPC). As part of this action, I was directed as City Manager to request these funds and a response from TPC no later than April 19, 2019.

SUBJECT **Public Works Post-Construction Survey, Consolidated Project Map, and Code Changes for Construction in the Public Right-of-Way (ROW)**

At the recommendation of several Council Members, the Department of Public Works has worked with the Communication and Information Services (CIS) Department to launch an online, post-construction survey for residents and businesses to complete once a Public Works construction project has been completed. At the start of every project, as part of the door hanger or project letter that serves as notification of the coming project, a unique project identification number will be included in the notification. Once the project is completed, residents and businesses will be able to answer eight yes/no questions and one open-ended question for other comments. The survey, which will be available in both English and Spanish, is scheduled to go live by June 1, 2019.

Also, at the recommendation of several Council Members, the Department of Public Works has worked with the CIS Department to create a consolidated map of bond projects, Dallas Water Utility projects, and Public Works maintenance projects. The consolidated map, which will be used for project identification, coordination and collaboration, is located at <https://gis.dallascityhall.com/bond/#/view/interdepartmental-projects>. The Department of Public Works has also consolidated its most-frequently requested maps, including the 2017 Bond Program, the Needs Inventory, and Right-of-Way Permits; the maps are located at <https://www.dallascityhall.com/departments/public-works/Pages/Data-and-Maps.aspx>.

Lastly, on May 22, 2019, the Department of Public Works will be bringing the Mayor and City Council an agenda item for consideration to revise a number City Codes pertaining to construction in the City's right-of-way (ROW). Over the past several months, the Department of Public Works has briefed and sought input from the Mayor and City Council, as well as the Mobility Solutions, Infrastructure & Sustainability (MSIS) Committee, on proposed changes to the processes and City Codes associated with working with the City of Dallas' ROW. Highlights of the proposed City Code changes include additional requirements for project notification, addressing noise from steel plates in the street, and more-stringent restoration requirements for streets with a pavement condition index (PCI) rating of 70 or higher.

SUBJECT **Sales Tax Receipts**

Sales tax receipts through March 2019 represent six months of FY 2018-19 actual revenue. Overall, sales tax collections for the first half of this fiscal year are better than budget for this time period by \$2.8 million.

The March 2019 sales tax receipts from the State Comptroller's Office are \$29.7 million which represents a 3.1 percent decrease in total collections compared to the same reporting period last year.

- March 2018 actual \$30,639,226
- March 2019 budget \$31,265,984
- March 2019 actual \$29,690,536

Although total collections for the month were down by \$948,690, the current collections for the month of March were only down by \$56,167. Current collections are more representative of current sales activity than total receipts. Since February 2010, this marks only the sixth time that current collections have dipped when compared to the same reporting period of the previous year. The last time we saw a dip in current period collections was in September 2017.

We continue to have steady growth in sales tax collections since the end of the recession. We do not see a change in our current overall trend of growth. In fact, over the most recent 12 months, sales tax receipts have increased by 4 percent. We will continue to monitor our sales tax forecast and receipts closely and keep you informed.



City Response (answer provided by department on May 3, 2019): Good morning Cassandra,

Thank you for your patience and understanding as we worked to get you this information. Please see the statement and summary below from the City of Dallas. If there is anything else I can assist you with, please let me know.

“The City of Dallas is still deeply saddened by the loss of David Walters. We continue to send our sincerest condolences to the Walters family.

Any loss of life is heartbreaking, and it compels us to take a closer look at policies currently in place to ensure we are working in the best interest of our employees and their families. During the March 25 Public Safety and Criminal Justice Committee meeting, the current policy survivors' benefits was discussed. Council asked that an analysis be completed and brought back to the committee. The date for the analysis to be completed is still pending.”

Please see the summary below to address your questions:

The City of Dallas (COD) offers Consolidated Omnibus Budget Reconciliation Act (COBRA) benefits to eligible dependents of employees who die while off duty. COBRA gives workers and their families who lose their health benefits the right to choose to continue group health benefits provided by their group health plan for limited periods of time under certain circumstances, such as death and other life events. These benefits for off-duty deaths are consistent with other municipalities.

At COD, surviving dependents are given a 60-day grace period to opt in or out of COBRA benefits, and if elected, the coverage is retroactive so that there is no gap in coverage. The COD also provides survivor support through a life insurance policy of

\$50,000 provided by the City. Death benefits are given to the appropriate beneficiary after a death certificate is presented.

David Walters' death was confirmed to be not on-duty because he was not on shift or working in any capacity for the City of Dallas and/or Dallas Fire-Rescue. In order for a not on-duty death to be classified as on-duty it has to meet certain criteria of Public Safety Officers' Benefits (PSOB) program or State of Texas, Employee Retirement System of Texas (ERS). To obtain employee's personnel records, such as an employee's retirement eligibility, an open records request must be filed.

April 30; Clayton Neville, Reporter/Anchor, WBAP/FLIF: We have noticed the fence and plastic covering the monument at Pioneer Park. could you tell me when the scheduled date of removal is? And/or what the planned process for removal is? Is there currently an appeal ongoing with the Landmarks decision to approve the confederate memorial from Pioneer Park? Or has that process cleared?

City Response: At this time no date has been set for removal and the city is currently looking to identify a vendor for the process. We will be happy to discuss a phone interview when there is more information to update you on. Two appeals were filed in April. The appeals have been scheduled for the City Plan and Zoning Commission on May 16, 2019.

May 2, 2019; Samantha Chatman, Investigative Reporter; We plan on interviewing this person in the next hour and were hoping to get a statement from the city. Last week, we informed our viewers that that they could file a claim with the city, but we're now hearing that the city is denying claims.

Can the city explain this?

City Response: The City of Dallas, as a municipality in Texas, is bound by the Texas Tort Claims Act when a claim is presented. The Act provides that a municipality is only responsible for property damage that arises out of the negligent use of motorized equipment by a city employee. Unfortunately, the vehicles that were flooded in the Love Field parking lot would not fall under this responsibility and the City would have immunity for these damages. Thus, claims submitted to the City will be denied.

The City of Dallas recommended that the vehicle owners report the claims to their insurance carriers to get immediate resolution of damages. If the vehicle owners insist on filing a claim, they can make a claim with the City by accessing the notice of claim form at:

I understand there are more than 80 projects to protect the city from flooding. Which ones are ready? Do you have a record of the most vulnerable areas?

City Response: Design activities by the US Army Corps of Engineers, related on the Cadillac Heights and Lamar Levees is expected to after the project agreement is

passed by the City Council in late May or early June. As part of the Dallas Floodway Extension, these projects are funded and constructed by the US Army Corps of Engineers and supported by the City. These projects are expected to be completed by December 2024, depending on weather conditions. Separate from these projects' funding, the 2006 and 2012 bond program included funds for residential buy-outs in the Cadillac Heights area for public facilities.

May 2, 2019; Arya Sundaram, Texas Tribune; I've been trying for some time to get in touch with a member of your transportation department, Towfiq Khan, who testified in the capitol on behalf of red-light cameras in your city. Specifically wondering about this: He said the city has seen a 70% reduction in all types of crashes at red-light intersections – and an 86% reduction in right-angle collisions. Do these numbers apply to all red-light intersections? Or only where there are cameras?

Can you give me his contact information?

City Response: Mr. Khan isn't available to speak, but the City's Automated Red Light Enforcement Commission (ARLEC) just met and Mr. Khan briefed them on a legislative update. The ARLEC meeting is available here - <https://dallastx.swagit.com/play/04302019-609>

May 2, 2019; Cynthia Lemus, Reporter, Univision; We are interested in as for an interview today respect the flood in this weather season. This weather can be severe in this season and we want ask about the plan to clean the trash in the street for possible flooding issue.

City Response: Please see responses to your questions below:

- What can residents do to help avoid flooding due to sewers full of trash?

Residents can assist with efforts to keep the storm drains and creeks clear of debris through a number of measures but particularly not blowing leaves and grass clippings into the inlets, removing standing debris away from inlets and reporting any visual blockages to 311 through call or use of the application and / or the website.

- What is your advise for the community when driving during rainy days?

Turn around, don't drown. Water can be deeper and moving faster than it appears and avoiding these situations is the safest alternative.

- Have people reported before problems with sewers in the city of Dallas?

The City does not have combined sanitary and storm sewers. Should residents notice areas where storm drainage systems do not appear to be functioning properly, please report to 311 as mentioned above.

- How can people take care of themselves during these rainy days, general advise?

Pay attention to the weather advisories and use good judgement when choosing routes to walk, bike or drive.

Tuesday, April 30th: NBC 5 (Hannah Everman) - I was just trying to check up on this on the log – does this mean it's a DFR unit involved in the accident? If so, do you have any details? Thanks!

City Response - I don't have accident details but I can tell you that a DFR engine was involved in an accident with another vehicle, at the 9400 block of Forest Lane, while heading back to the station from a response. No one from the engine was injured, but the driver of the other vehicle was taken to the hospital with non-life-threatening injuries. The accident happened at approximately 11:15.

Sunday, May 5th: All local news desks - Is there any information available regarding a possible water rescue in the 8700 block of TX-310 around 4:15am this morning?

City Response - Units were assigned to this call around 3:45 this morning. Information in the initial incident report indicated that a man was trapped in a ditch, in his vehicle along Highway 310, in rising waters. I can't confirm that an actual rescue was conducted; but after he was located, the incident report also indicates that the man was "out of the water and walking out" at approximately 4:30. He was not taken to the hospital.
