

PLAN COMMISSION MINUTES

The City Plan Commission held a regular Zoning Hearing on March 29, 2007, with the bus tour starting at 9:07 a.m. followed by the briefing starting at 11:16 a.m. in Room 5ES and the public hearing at 1:30 p.m. in the City Council Chambers of City Hall. Presiding were Robert Weiss, Chair and Angela Marshall, Vice Chair. The following Commissioners were present during the hearing: Jeff Strater, Clarence Gary, Ann Bagley, Erma Jones-Dodd, Chris Buehler, Sally Wolfish and Robert Ekblad.
