ADJOURNMENT

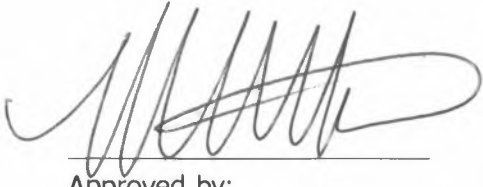
