# Field Study

### January 2014

- 50 volunteer patrol officers selected
- Used VieVU LE2 body cameras
- Cameras "live" in all 7 patrol divisions

## June 2014

- Vendor presentations
  - · Live demos of cameras and hands-on functionality

### August 2014

• Additional 30 volunteer officers selected and trained in preparation for forthcoming field study (now includes Traffic, Narcotics, METRO officers)

### September 3 thru October 28, 2014

- DPD conducts field study of 5 different body camera units and software
- 1 week rotations
- Survey completed for every unit per officer

### December 2014

• Final survey calculations and reports from field test completed



# Microwave Upgrade

- Current microwave system is in the final phases of construction to be upgraded
- Increase the size of the "pipe" to support moving video to City Hall
- Video would use significant bandwidth
- Upgrade will allow for future growth and can be used for additional purposes beyond the video

## How it works



All video management features: evidence case workflow, adding case notes, video playback and review, video redaction, and video downloading, is accessed through a Department networked computer that is connected to the Cloud server via the internet.

# **Cloud Storage**

- Video would be moved to City Hall from substations via microwave network and transferred to the cloud
- Cloud storage decreasing in price
- Software built-in manages all the video
  - Segments video per camera/officer
  - Tags videos
  - Search tools
  - Web based
  - Secure
  - Can open portals to distribute video other law enforcement, media, District Attorney
  - Ongoing cost associated with moving video from City Hall to the cloud
  - Requires fewer personnel to manage
  - Initial purchase approximately \$3,250 per unit

# Implementation

## **Program Launch Timeframe**

- In negotiation on final pricing and contract
- Moving in parallel to microwave upgrade
- Goal is to have initial purchase completed by 6/30/15
- Initial phase would be for 200 cameras with the intent to grow additional 200 cameras per year up to 1,000 units
- 1,000 units would equip one half of patrol

# **Domestic Violence Facts**

- One in every four women will experience domestic violence in her lifetime
- An estimated 1.3 million women are victims of physical assault by an intimate partner each year
- 80% of domestic violence victims are women
- Females who are 20-24 years of age are at the greatest risk of nonfatal intimate partner violence
- Most cases of domestic violence are never reported to the police

# History of Lethality Assessment Program

- Designed by Dr. Jacquelyn Campbell of John Hopkins University
- Department was awarded grant in April 2012
- Implemented program October 2012
- The Family Place & Genesis Women's Shelter are our partners

# Lethality Assessment Program Goals

Reduce domestic violence by:

Identifying victims who are at the greatest risk of serious bodily injury or death,

- Reduce domestic violence murders
- If necessary, get victim away from the offender
- Encourage victims to allow domestic violence advocates to help

# Purpose of Assessment

- Identify victims in need of greater intervention by the High Risk Team
- Raise victim's awareness of level of danger
- Provide Courts and District Attorney's Office with offender information regarding condition of release on bail
- Indicate need for ankle monitoring



Note: The questions above and the criteria for determining the level of risk a person faces is based on the best available research on factors associated with lethal violence by a current or former intimate partner. However, each situation may present unique factors that influence risk for lethal violence that are not captured by this screen. Although most victims who screen "positive" or "high danger" would not be expected to be killed, these victims face much higher risk than that of other victims of intimate partner violence.

# **Summary Facts**

- Participation is voluntary, victims can refuse to answer
- Officers are required to offer screening in all intimate partner violence offenses
- In 2013 and 2014, 1,645 victims reported 3,700 offenses
- 31 victims generated 181 calls for police
- Numbers in LAP decrease as repeat victims are aware of the dangers and services available

## Summary

- The department will continue to use the LAP as a tool to aid in the prevention of domestic violence
- The Domestic Violence Unit will continue to use the assessment results to identify victims that may be at a higher risk of death

### What is PAL?

A youth community engagement program that utilizes educational, athletic and recreational activities to create trust and understanding between police officers and youth.





### What is PAL?

Encourages youth to make better life choices and to avoid activities such as gangs, drugs, and criminal activity by offering positive, engaging experiences with law enforcement.





### What is PAL?

- Dallas PAL became an active chapter of the National PAL in 2007



#### **SUBJECT:** Designation of Adjudication Hearing Officers for Certain Violations

Staff seeks the Committee's approval to designate hearing officers for adjudicated hearings on two types of civil citations: red-light camera citations and school bus stop-arm citations, which are both enforced with photographic images. Together, these two types of citations number over 50,000 annually, with about 7,500 of the cases appealed to City hearing officers. Administrative adjudication provides a forum for citizens to resolve the citations quickly and fairly, relieving a work flow burden on the municipal courts. Nevertheless, citizens retain the right to appeal to a municipal court, should they wish to do so.

#### **School Bus Stop Arm Citations:**

On May 23, 2012, City Council passed Ordinance No. 28654, which amended Chapter 28 of the Dallas City Code to create a civil offense and a civil penalty for unlawfully passing a stopped school bus with its stop arm extended and red lights flashing, and to provide for photographic enforcement and administrative adjudication of school bus stop arm violations. The ordinance created the City's Automated School Bus Stop Arm program.

The City also entered into an interlocal agreement with Dallas County Schools (DCS) to utilize video equipment on DCS-owned and operated buses to capture violations of the ordinance. That interlocal agreement was authorized by Council on May 23, 2012, by Council Resolution No. 12-1388. The City and DCS entered into the interlocal agreement shortly thereafter, and the Automated School Bus Stop Arm program with camera enforcement was underway.

One requirement of Ordinance No. 28654 is that City Council designate hearing officers to adjudicate appeals of school bus stop arm citations. To that end, Agenda Item No.45 on the May 27, 2015 agenda is the designation of the following staff, as recommended by the City Manager, to be hearing officers for the Automated School Bus Stop Arm program:

This agenda item also ratifies all decisions made by these hearing officers in past appeals of school bus stop arm citations.

#### **Red-Light Camera Citations:**

On April 12, 2006, City Council passed Ordinance No. 26305, which amended Chapter 28 of the Dallas City Code to create a civil offense for a red-light violation at a camera-enforced intersection. On November 5, 2007, City Council passed Ordinance No. 26988, which conformed the City's red-light camera ordinance to state law and provided for civil fines not to exceed \$75 per offense. On December 12, 2007, the Council passed Resolution No. 07-3793, which designated hearing officers for adjudication of red-light-camera citations. Several of the hearing officers designated by that resolution continue to perform their duties as hearing officers. However, new staff members have joined the Adjudication Office, and staff recommends that the Council designate the following persons as hearing officers to adjudicate appeals of red-light camera citations, and to ratify any past hearings for these hearing officers:

Staff is seeking support from the Public Safety Committee to designate these hearing officers and to ratify past decisions made by these officers on appeals of red-light camera citations and school bus stop-arm citations. If the Committee concurs, this item will be placed on the May 27, 2015 City Council Agenda.

#### **SUBJECT:** Renewal of the Interlocal Agreement for the School Bus Stop Arm Enforcement Program

After briefings from Dallas County School (DCS) on the growing number of incidents of motorists unlawfully passing stopped school buses and the high potential for injury or death to students and the public, on May 23, 2012, City Council adopted Ordinance 28654 which created a civil offense and civil penalty for unlawfully passing a stopped school bus with its stop arm extended and red lights flashing.

In a student safety partnership with DCS, City Council authorized execution of (2) two ILA's. The first ILA authorized DCS to administer and enforce the School Bus Stop Arm Program. The existing ILA expires on June 24, 2015 and both parties desire to renew this student safety partnership.

Under the Interlocal Agreement for the School Bus Stop Arm Enforcement Program, DCS is responsible for monitoring and recording passing traffic when a stop arm is deployed on the bus. DCS hired peace officers to review the videos and determine whether violations have occurred and issue citations for violations that carry a \$300 civil fine. In addition, DCS is responsible for all collection efforts on school bus stop arm citations. The City is responsible for handling any hearings or appeals for adjudication of school bus stop arm violations, whether administratively or in Municipal Court.

The second ILA transferred the responsibility, management, and expense of the school crossing guard program from the City to DCS beginning in August 2012. The transition of the school crossing guard program to DCS has been a successful and valuable component of the student safety partnership.

To offset program deficits from management of the school crossing guards, certain expenses associated with the operation of the school crossing guard program can be funded by the joint escrow account. In no event, however, shall the balance of the account fall below \$250,000.

The term of the ILA for the School Bus Stop Arm Enforcement Program is being extended to coincide and synchronize with the termination date of the ILA for the School Crossing Guard Program to maintain the longevity of the student safety partnership.

The City is seeking a favorable recommendation from the Public Safety Committee to authorize a renewal of the ILA with Dallas County Schools. This item will be placed on the City Council Agenda on May 13, 2015.
