SUBJECT Update – Agenda Item #30, December 8, 2021 City Council Agenda Option to Renew Letter, Five-year Lease Extension – DPD Police Academy

On December 8, 2021, the Dallas City Council considered the following item, as amended:

Authorize an Option to Renew letter to an existing lease agreement with Sealy Executive Center, L.L.C. to exercise a one-time renewal option to extend the lease agreement for an additional five-years for approximately 12.7395 acres of land improved with a vehicle obstacle driving course, and a 31,050 square foot building with classroom, office and warehouse space located at 5310 Red Bird Center Drive, and for approximately 27,051 square feet of classroom and office space located at 5610 Red Bird Center Drive, to be used by the Police Training and Education Division for the period August 1, 2022 through July 31, 2027 - Not to exceed \$5,587,310.74 - Financing: General Fund (subject to annual appropriations)

This item was approved and further amended to include a request to amend the lease, for the City's right to terminate after three years during the renewal term. On December 10, 2021, staff provided a written request to Sealy Executive Center, L.L.C., ("Landlord") to amend the lease to include early termination language, providing for the City's right to terminate at any time after three years, in its entirety or by severability for 5310 Red Bird Center Drive or 5610 Red Bird Center Drive, individually. On December 15, 2021, the Landlord provided a response to the City's amendment request and has declined to grant the City's request to amend the lease. The Landlord further acknowledged, the City has the right to terminate at the end of each fiscal year for non-appropriation, with no penalty; consequently, no additional early termination rights will be granted. The Landlord's acknowledgment is in accord with the Lease rental provisions allowing City to terminate for non-appropriation and not incur any penalty or rental liability for any unused Lease term.

Staff will proceed with administrating the Option to Renew Letter under the existing terms of the Lease to provide for the continued use of the leased premises for DPD's Police Academy. The renewal term will be for five years, commencing August 1, 2022 through July 31, 2027, subject to annual appropriations.

SUBJECT Office of Homeless Solutions – Holiday Street Charity

The purpose of this memorandum is to provide information on OHS' activities concerning street charity, ways to report events, and ways to redirect these requests to more sustainable methods of engagement.

'Tis The Season!

Per the Panhandling Deflection Initiative presentation to the Government Performance and Finance Management Committee on October 25, 2021 street charity is defined as the donation and distribution of food, beverages, money, household items, clothing and footwear to persons experiencing homelessness by members of the general public. While this compassionate act is extremely valuable and appreciated, OHS requests that entities wishing to provide these gifts, partner with existing charities and homeless service providers to ensure that the engagement has a longer-term impact. The most prevalent street charity event is street feeding and these events often take place next to area shelters, resulting in mass amounts of trash, the blocking of traffic, and bringing together of new encampments in areas where these events are frequent. The aftermath of these events is left for the nearby shelters to clean up on Monday mornings. Instead of these events happening in parallel with the aforementioned, unintended consequences, we and our partnering providers and non-profits ask that interested parties reach out to us for ways to get involved that provides not only food but services like showers, laundry, hygiene kits, employment training, and more. This partnership transforms the one-time service into a longer conversation, offering the opportunity for recipients to receive far more than one meal or item.

What Can You Do?

The attached flyers in English and Spanish have been shared with your offices and the public for this purpose. As a result, OHS has already received several requests for partnership and are busily connecting them with the appropriate partners. We are also partnering with Code Compliance, Sanitation, and Downtown Dallas Inc. this week to place 40 roll carts in the Downtown District and 20 roll carts near The Bridge and Austin Street Shelters, where we know many of these events take place. These will be deployed on Wednesday with Code's Illegal Dumping Team taking the lead on this.

If you are aware of a street charity event, please direct them to contact OHS or an area homeless service provider per the resources in the flyer. The goal is to create

partnerships around these events, so they do not take place on the street, with no additional services offered or plan for waste management and flow of traffic.

- The Bridge provides free meals three times per day, every day of the year.
- Homeless services providers distribute shoes and clothing free of charge.
- Free laundry facilities and supplies are available at various locations.
- Street charity encourages persons experiencing homelessness to remain on the street instead of going to a shelter to obtain the services necessary to exit homelessness.
