The following is the current schedule for the upcoming public meetings, which are scheduled in coordination with Forward Dallas public meetings:



This memorandum is to provide you with an update on Development Services Department (DSD) activities and progress.

CUSTOMER INITIATIVES

The next scheduled Lunch and Learn training is being held on Friday, September 30, 2022, at the Development Services Training Center located at 400 S. Zang Blvd. Dallas, TX 75208. The training is scheduled from Noon until 1:30 PM. DSD Land Management staff will cover best practices for Construction Management.

TECHNOLOGY

DSD continues to partner with ITS and Gartner to finalize the Statement of Work (SOW) with Accela for the new land management system. A new schedule has been revised to facilitate completion of the process by October 14, 2022, pending Accela's availability. DSD has coordinated and will send executive staff to the upcoming Accelerate Software Conference October 2-6, 2022, to collaborate with municipalities from across the country. These sessions identify best practice implementation for the Accela product.

HIRING AND RECRUITMENT

DSD will host its next Hiring Event at the J. Erik Jonsson Library on Tuesday, October 18, 2022. The details are still being finalized; however, the department is seeking candidates for hard-to-fill technical positions including Combination Plans Examiners, Combination Inspectors, Engineers and Senior Plans Examiners.

NEW SINGLE-FAMILY RESIDENCES, REMODELS/ADDITIONS PERMITTING

Since September 1, 2022, the Residential Plan Review Team has created 330 New Single-Family permits and issued 160.


Since September 12, 2022, the Rapid Single-Family VIP Program (RSVP) team has produced the following:

SUBJECT **Launch of the Domestic Violence Dashboard**

At the request of the Domestic Violence Task Force, the Office of Data Analytics and Business Intelligence has created the [Domestic Violence dashboard](#). The interactive dashboard has three primary objectives: 1) to increase public awareness about domestic violence; 2) to display data from the Dallas County District Attorney's Office and local domestic violence shelters; and 3) to measure domestic violence crime trends over time.

The dashboard's first page displays domestic violence related crime numbers, an area map, trends, and demographic information on victims of domestic violence. The data is collected from the Dallas Police Department and refreshes daily. The second page displays domestic violence cases and their outcomes from the Dallas County District Attorney's Office. The last page displays family and victim data from two of the City's largest domestic violence shelters, the Family Place and Genesis Women's Shelter. Pages 2 and 3 will refresh once a month. The dashboard also provides domestic violence hotline numbers, victim resources, and a link to the City of Dallas' Domestic Violence Task Force webpage.

SUBJECT **Stemmons Building Update**

Background

On August 10, 2022, the City Council authorized the acquisition of a commercial building and parking garage, located at 7800 N. Stemmons Freeway, to primarily serve as a new Development Services permitting office. Referred to as Stemmons Building, the building acquisition was for an amount not to exceed \$14,165,000.00. Following the City Council authorization for acquisition, staff completed the closing of this transaction, and the City took possession of the Stemmons Building on September 23, 2022. This is aligned with the City Manager's R.E.A.L Impact: 100-Day Plan that the City will acquire a new facility for Development Services to implement a "one-stop shop" experience for builders, developers, and residents.

As part of the transfer of property ownership of the Stemmons Building, the City assumed existing leases of tenants within the property. During the transition process, staff will continue to work with the existing tenants while office space is planned and prepared for City staff.

Next Steps

The City Project Team is finalizing details of Phase I of the transition plan, which entails space planning and office preparation to move the Development Services Department (DSD) and other supporting departments currently housed at the Oak Cliff Municipal Center (OCMC). Phase I of the transition plan is anticipated to be completed in the early part of the second quarter of Fiscal Year (FY) 2023 and departmental employees are expected to move to the Stemmons Building in mid-FY 2023.

During the Phase I renovations, the City Project Team will begin developing plans for Phase II modifications depending upon space made available through the termination of existing tenant leases. While departments and employees currently housed at OCMC will be the priority teams transitioning to the Stemmons Building, City staff will evaluate what other departments or teams can occupy space in this building.

Tentative Project Schedule

Given the details provided for the next steps described above, staff anticipates Phase I will be underway between October 2022 and March 2023, and will complete the following:

- All necessary abatements,
- Finalize 1st, 2nd, 5th, and 9th floors planed layouts,
- Finalize mechanical, engineering, and plumbing plans (MEPs),
- Phase I office renovation work.



The Dallas Real Time Rapid Rehousing (D.R.T.R.R.) team of homeless service providers, co-led by the Office of Homeless Solutions (OHS) and Metro Dallas Homeless Alliance (MDHA), is currently targeting several encampments, which will result in closure through the housing of those unsheltered individuals throughout the year. The team will outreach to these sites and meet with various persons experiencing homelessness to assess their needs in preparation for site closure via housing. During this time, the OHS Street Outreach Team will continue to engage with unsheltered residents through normal street outreach, connecting people with the needed resources, such as: getting IDs, working with Community Courts on expunging eligible tickets and offenses from their records, identifying medical



SUBJECT **Upcoming Fleet Initiative – GPS Redeployment – Internal Staff Kickoff Meeting**

In 2014, the City of Dallas contracted with CalAmp to install global positioning services (GPS) devices on City vehicles. These services allow the City to monitor the location and utilization pattern of its vehicles and equipment to make management decisions on right sizing the fleet and potentially fleet reductions. The initial roll-out included approximately 1,300 devices. An expansion and redeployment of this technology was planned and funded in 2020 but was delayed because of challenges with COVID-19.

Since 2014, GPS technology and the options/features available have changed considerably. CalAmp has recently introduced a new and upgraded web portal that will provide enhanced utilization metrics and reporting along with a telematics solution that will feed into the City's fleet management system called (M5). Equipment and Fleet Management (EFM) anticipates accelerated interests in the GPS functionality city-wide. Training for city staff on the new portal has commenced over the past few months and CalAmp is scheduling the shipment of approximately 2,000 thousand devices to the City in preparation for installation.

With the need for real-time data analytics and subsequently data-based decision making, GPS is a desired tool for fleet management governance. An internal "Kickoff" meeting for city staff is being scheduled on 10/18/22 where CalAmp will answer questions on the GPS products available and EFM will brief customer departments on the roll-out of the installations. EFM is scheduled to brief fleet initiatives at the City Council Briefing on November 2, 2022 and will address the planned roll-out.
